#### SUPERVISOR MEETING

## MANAGERS REPORT

#### ACT 111 POLICE NEGOTIATION

• Township Manager Christine Capozzi will contact the Township's labor counsel this week regarding outstanding issues with the police contract negotiations.

#### THE COMM HVAC PROJECT FINANCES & USDA LOAN

- There is not an update to the USDA loan.
- Supervisor Cheryl Murnin is the Waverly Community House Liaison. Cheryl will schedule a
  meeting with Michelle Hamilton, Executive Director of The Comm and Mike Poremba, Board of
  Trustees President, to discuss the operating agreement conditions and other items of concern
  raised by supervisors.

#### **ZONING AMENDMENT**

- Township Manager Christine Capozzi presented supervisors with a zoning ordinance draft
  amendment. The proposed amendment is to revise the Place of Worship/Assembly definition and
  to revise the Accessory Structures and Uses section and District Quick Views. Christine
  explained this amendment draft will be sent to Planning Commission members and to Planning
  Commission Solicitor Attorney Bill Jones for their final review.
- Christine will advertise the Notice of Public Hearing, Notice of Intent to Amend the Zoning Ordinance in the paper according to the required advertising guidelines.

#### HARB DISTRICT PROPERTY

• Township Manager Christine Capozzi reported she still has not received responses from letters sent to HARB property owners.

### DALTON FIRE COMPANY - FIRE SERVICES AGREEMENT

- Township Solicitor Attorney Malcolm MacGregor will contact Dalton Borough's Solicitor to discuss information requested from the Dalton fire department.
- Once received, Christine will arrange a meeting with Township Solicitor Attorney Malcolm MacGregor, the Fire Department's Solicitor and representatives from Dalton Borough and Dalton Fire Company.

## MAINTENANCE SUPERINTENDENTS REPORT

- Township Manager Christine Capozzi and Director of Public Works Tom James attended a preconstruction meeting with HRG stormwater engineers, Scott Smith and Mark Spatz, and Rutledge Excavating. The contractor will begin the project in the next few weeks, and complete in the Spring.
- Tom also mentioned the ditches along Glenburn Road need clearing. Tom will secure quotes for this work.
- Tom reported that he and Township Engineer Ned Slocum are researching options other than UV lighting to reduce the chlorine levels in the Amphidrome Wastewater treatment plant. Tom will provide a follow-up at a future supervisors meeting.

There being no other business to come before the Supervisors, the supervisors meeting was again adjourned. Prior to this meeting, Supervisors had an executive meeting to discuss litigation involving police department bargaining agreement negotiations and a litigation issue.
